Trick or Treat will be October 31, 2015 from 6:00 p.m. until 7:30 p.m.

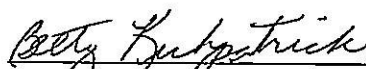
Chief Sutton will be off September 17 and 18.

September 14, 2015, cont'd.

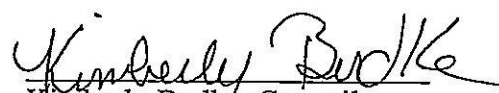
Chief Sutton ordered two banners for the Village for \$100.00 for both.

Mr. Jones made a motion to adjourn, and Ms. Miller seconded it. The motion carried, all voting yes.

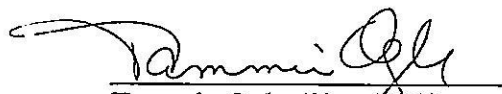
