Regular Village Council Meeting
March 13, 2017

Present: Mayor Betty Kirkpatrick, Kim Budke, Kathleen Miller, Bobbie Thomas, Dale Owsley, Wayne Hill and Fiscal Officer Tammie Ogle.

Mayor Kirkpatrick called this meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Fiscal Officer presented the minutes of the previous meeting to the Council, as well as the Warrant Register, Revenue Status, and Appropriation Status Reports, and the February, 2017 Bank Reconciliation. Ms. Miller made a motion to accept the minutes, and Ms. Thomas seconded it. The motion carried, all voting yes. All other reports and the Bank Reconciliation were read and approved.

Mayor Kirkpatrick recognized Roger Adkins, who came with Jim and James Riley to discuss the Village citing the business the own on Fite Avenue due to trash vehicles. They feel that they are being singled out. Chief Sutton and Mayor Kirkpatrick explained that the Village had received complaints about the vehicles. They thanked Council for their time.

Mayor Kirkpatrick recognized Kelly Cole from Brown County CDBG, who came to discuss the CDBG and Community Allocation Grants. She explained the process and parameters. They are now on a two year rotation.

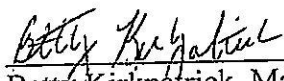
Ms. Miller made a motion to pay all bills, and Ms. Budke seconded it. The motion carried, all voting yes.

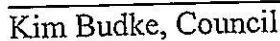
Chief Sutton introduced John Amole, who he would like to have as an auxiliary officer. Mayor Kirkpatrick appointed him, and then swore him in.

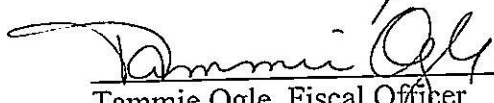
The Maintenance department will rent a stump grinder for the park.

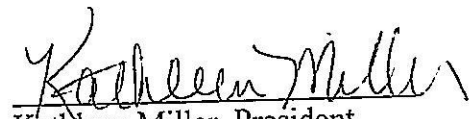
Ms. Budke made a motion to adjourn, and Mr. Hill seconded it. The motion carried, all voting yes.

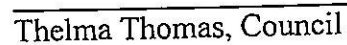
