Regular Village Council Meeting
May 8, 2006

Mayor Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting to the Council, as well as the Warrant Register, Fund Status, Revenue Status and Appropriation Status reports, and the April 2006 Bank Reconciliation. Ms. Kirkpatrick made a motion to accept the minutes as presented, and Mr. Tolliver seconded it. The motion carried, all voting yes.
