

VILLAGE OF HAMERSVILLE

ORDINANCE NO. 1992-04

AN ORDINANCE SETTING THE ELECTRIC RATES CHARGED TO THE VILLAGE OF HAMERSVILLE, OHIO, AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the Village of Hamersville, Brown County, Ohio, at least a majority of its members concurring:

Section 1. Residential Service Rate.

The Residential Service Rate shall apply to single family residential consumers for all domestic uses. Detached buildings such as garages and/or barns, if used solely for residential purposes, may be served from the residential meter.

Over	220 Kwh	\$05.428 per Kwh

In addition to the above charges there shall be an additional charge known as the "fuel add on charge" which shall be based upon the fuel add on charge billed to the Village by the Cincinnati Gas and Electric Company and shall be the same rate per kilowatt hour and charged to the Village of Hamersville.

Section 2 Commercial Service Rate.

A Commercial Service Rate shall apply to all consumers for general light and power service for purposes other than residential use. As used herein, the term "for purposes other than residential use" shall be construed to include those situations where electrical power is consumed by the user in connection with the operation of a business such that electricity so consumed is directly used in the business operations as opposed to being merely incidental thereto. Detached buildings, garages, and/or barns used in connection with the operation of a business may not be served through a residential meter.

First	40 Kwh	\$0.13.252 per Kwh
Next	40 Kwh	\$0.11.482 per Kwh
Next	140 Kwh	\$0.08.785 per Kwh
Over	220 Kwh	\$0.06.028 per Kwh

Section 3 The clerk shall add to each monthly bill to residential and commercial consumers the pro rated adjustment for "Fuel Add on Costs" as specified by the Cincinnati Gas and Electric Company, multiplied by a factor of 1.11. The clerk shall total the usage amount based upon the above schedule and add the pro-rated "Fuel Add on Costs" as calculated by Section 3, which shall be known as the "Gross Amount Due" for each consumer

Section 4. The Clerk shall provide a discount for each consumer (known as the "Net Amount Due") by deducting 10 per cent from the Gross Amount Due. All residential and commercial consumer bills paid and received by the Clerk on or before the 20th day of the month in which it is due, shall pay the Net Amount Due. All residential and commercial consumer charges paid after the 20th of the month shall be determined by the Gross Amount Due. Each bill issued by the Clerk shall state the Net Amount Due and Gross Amount Due and specify that the Net Amount Due must be paid by the 20th of the month in which it is due.

Section 5. Residential and commercial consumers who have not paid the amount due (including penalty, when applicable) net or gross amount due by the end of the month in which it is due shall be subject to disconnection in accordance with Ordinance No. 1991-9.

Section 6. That Ordinance 1988-5 be and hereby is repealed.

Section 7. This Ordinance is hereby declared to be an emergency Ordinance in that it is necessary for the public health, safety, and welfare of the inhabitants of the Village of Hamersville, Ohio, and more particularly so that adequate electric rates and charges can be made so as to maintain the electric fund of said Village and to provide adequate utility service to the inhabitants of the Village of Hamersville, Ohio. Rates for electric service shall become effective on May 15, 1992 and shall be included in the July 1, 1992 bill
