The Clerk Treasurer presented all bills to the Council as follows:

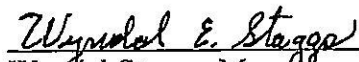

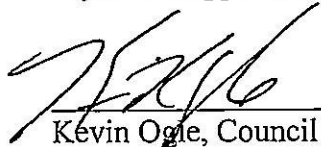
Mr. Talbott made a motion to pay all bills as presented. Mr. Staggs seconded the motion, and it carried, all voting yes.

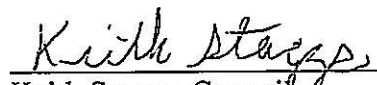

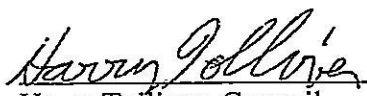

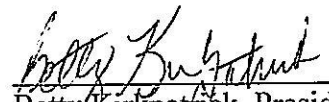
Mr. Ogle made a motion to adjourn, and Ms. Kirkpatrick seconded it. The motion carried, all voting yes.

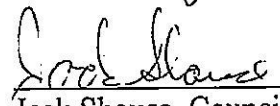

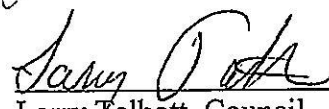

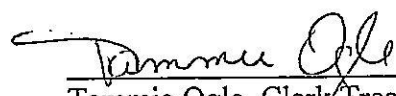
