**Regular Village Council Meeting**  
**May 9, 2016**

Ms. Budke made a motion to pay all bills, and Ms. Watson seconded it. The motion carried, all voting yes.

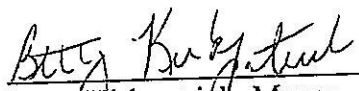
May 9, 2016, cont'd.

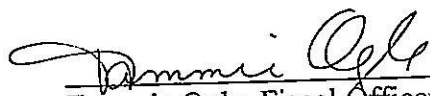
