Ms. Watson made a motion to appoint Ms. Kirkpatrick President of Council. Ms. Ernst seconded the motion, and it carried, all voting yes.

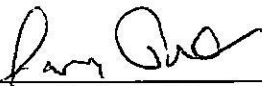
Mayor Staggs suggested keeping the Committees the same as last year, and the Council agreed.

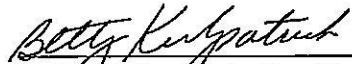
Skip will order 36 flags. The Council discussed the picnic tables at the park. They decided not to fix them.

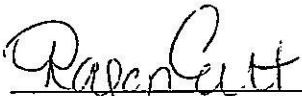
Skip will clean up the cul de sac on Adkins and the vacant house on Bank Street.

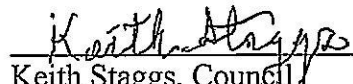
The Gray Cruiser caught fire. It will cost around \$500 to fix it.

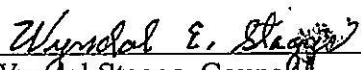
Ms. Kirkpatrick made a motion to adjourn. Mr. W Staggs seconded the motion, and it carried, all voting yes.

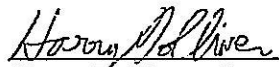

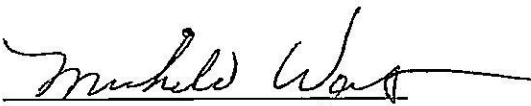

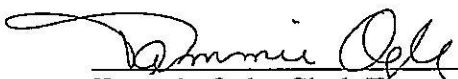
