Regular Village Council Meeting
June 9, 2005

Present: Mayor Wyndal Staggs, Harry Tolliver, Larry Talbott, Keith Staggs, Jack Shouse, Betty Kirkpatrick, Kevin Ogle and Clerk Treasurer Tammie Ogle.

Also Present: Sesame Fultz, Chief Jim Canter, Cecelia Potts and Janet Walters.

Mayor Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting, as well as the Fund Status, Warrant Register, Revenue Status and Appropriation Status reports, and the May 31, 2005 Bank Reconciliation.

The Council read and approved the Financial Reports and the Bank Reconciliation. Ms. Kirkpatrick made a motion to accept the minutes as presented. Mr. Talbott seconded the motion, and it carried, all members voting yes.

Mayor Staggs recognized Sesame Fultz, who is angry that Council allowed a resident on Fite Avenue to move a trailer into town without the add-on we required from her. The Council explained that variances are granted, or not, on an individual basis. The Council also reminded her that her add-on has not been installed within the 90 day time limit they allowed her.

We have a resident on Fite Avenue who is fighting our Ordinance #237. She has put a mailbox up. The Police Chief will ask her to take it down since she is in violation of said Ordinance.

Mayor Staggs recognized Janet Walters, who came to complain about a tree she claims is dead on her neighbor's property. Ms. Walters is afraid that this tree will fall on her carport. The Council informed her that there is nothing that they can do for her.

The streets will be swept June 21st.

Mayor Staggs thanked the Police Chief and the other officers for their hard work and volunteer hours.
