

RESOLUTION NO. 1981-2

A RESOLUTION OF THE TRUSTEES OF THE BOARD OF PUBLIC AFFAIRS OF THE VILLAGE OF HAMERSVILLE, BROWN COUNTY, OHIO, INCREASING THE ELECTRIC RATES CHARGED TO THE ELECTRIC CUSTOMERS OF THE VILLAGE OF HAMERSVILLE, OHIO.

BE IT RESOLVED by the Trustees of the Board of Public Affairs of the Village of Hamersville, Brown County, Ohio, all members thereof concurring as follows:

SECTION I. WHEREAS, the cost of purchasing electric utility service from the Cincinnati Gas & Electric Company has increased to the Village of Hamersville and that such increases have been reviewed by the Board of Public Affairs, and it further appears that in order to maintain the solvency of the electric fund, it is necessary and recommended by the Board of Public Affairs that increases be made in the rates charged to customers of the electric utility service of the Village of Hamersville, Ohio.

SECTION II. The electric rates and charges, also known as a rate schedule, which shall apply beginning October 15, 1981, to be billed December 1, 1981, to the residential customers of the Village of Hamersville, Ohio, are as follows:

First	40 kwh	at	8.953¢ per kwh
Next	40 kwh	at	7.760¢ per kwh
Next	140 kwh	at	5.936¢ per kwh
Any additional kwh		at	4.075¢ per kwh

There will be a Fuel Add On Cost, which will be adjusted monthly according to the cost from the Cincinnati Gas & Electric Company. The fuel cost for September, 1981 from the Cincinnati Gas & Electric Company was 0.003208¢ per kilowatt hour.

SECTION III. The electric rates and charges, also known as a rate schedule, which shall apply beginning October 15, 1981, to be billed February 1, 1981, to the commercial customers of the Village of Hamersville, Ohio, are as follows:

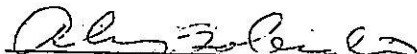
First	40 kwh	at	9.949¢ per kwh
Next	40 kwh	at	8.620¢ per kwh

Next 140 kwh at 6.595¢ per kwh
Any additional kwh at 4.526¢ per kwh

There will be a Fuel Add On Cost, which will be adjusted monthly according to the cost from the Cincinnati Gas & Electric Company.

SECTION IV. A penalty of ten per cent (10%) will be added to any bill which is not paid on or before the 20th day of the month in which it is due. If the bill has not been paid by the last day of the month in which it is due, service will be discontinued.

SECTION V. This Resolution is hereby declared to be an emergency Resolution in that it is necessary for the public health, safety and welfare of the inhabitants of the Village of Hamersville, Ohio, and more particularly so that adequate electric rates and charges can be made so as to maintain the electric fund of said Village in a solvent condition and so that adequate utility service to the inhabitants of the Village of Hamersville, Ohio, can be provided and this Resolution shall be in immediate effect upon its passage.
