Regular Village Council Meeting
December 8, 2003

Mr. Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting. Ms. Kirkpatrick made a motion to accept the minutes as presented, and Mr. Talbott seconded the motion. The motion carried, all members voting yes.

Mr. Ogle made a motion to leave the contract the same for one year, and Mr. Johnson seconded the motion. The motion carried, all voting yes, except Mr. Talbott, who voted no. Mr. Ogle made a motion to adopt Resolution 2003-14, to
