

RESOLUTION NO. 1986-1

VILLAGE OF HAMERSVILLE, BROWN COUNTY, OHIO

A RESOLUTION EMPLOYING A VILLIAGE SOLICITOR FOR THE YEAR 1986

BE IT RESOLVED by the Council of the Village of Hamersville, Brown County, Ohio, two-thirds (2/3rds) or more of all members thereof concurring as follows:

SECTION I. That Stanley K. Purdy, 300 West Grant Avenue, Georgetown, Ohio, be employed as Village Solicitor for the Village of Hamersville, Brown County, Ohio for the year 1986.

SECTION II. That the Mayor and the Clerk of this Village be, and they hereby are, authorized to sign an agreement with Stanley K. Purdy to employ him as Solicitor for the Village of Hamersville, Brown County, Ohio for the year 1986 at the rate of \$400.00 per year for regular and ordinary services and at the rate of \$50.00 per hour for legal services not considered as ordinary and regular services.

SECTION III. That this Resolution shall be in full force and effect from and after the earliest period allowed by law.

## AGREEMENT

This Agreement made and concluded by and between the Village of Hamersville, Brown County, Ohio and Stanley K. Purdy, Attorney At Law, 300 West Grant Avenue, Georgetown, Ohio.

1. The Village of Hamersville hereby employs and Stanley K. Purdy hereby accepts employment as Solicitor for the Village of Hamersville, Brown County, Ohio for the year 1986.

2. The regular and ordinary services of said Solicitor shall include attending Council meetings as deemed necessary by the Village Council, preparing routine ordinances and routine legislation.

3. Ordinary and regular legal services shall not be deemed to include the Solicitor acting as Village Prosecutor in criminal cases, or in Mayor's court, civil cases in any courts and shall not include services rendered in connection with capital improvements, bond issues, such as general obligation bond issues, assessment bond issues, or assessment proceedings or revenue bond issues nor shall it include collection work or the preparation of specialized legislation of unusual length or requiring extraordinary skills.

4. Legal services not considered ordinary and regular services shall be billed by Stanley K. Purdy to the Village of Hamersville on an hourly basis at the rate of \$50.00 per hour.

5. For the performance of the regular and ordinary services as Solicitor, Stanley K. Purdy shall receive the sum of \$400.00 payable quarterly.
