Mayor Bowyer called the meeting to order at 6:32 P.M.
The first order of business was to approve the sewer agreement
between Hamersville and Mt. Orab.

Mr. Leicht reported that Mt. Orab had accepted the agreement
with some very minor changes.

Mayor Bowyer read ORDINANCE 1995-18 for the first time.

Rumpke with the new rate being \$7.10 Per Month (Seven Dollars
and Ten Cents) Mr. Neu motioned to accept seconded by Mr. Boling.

Sowers: YEA. Voting: NAY: None. MOTION CARRIED.

The judges will be Mayor Bowyer, Ms. Sowers, Martha Hanes, and
Kay Elliott.

The Clerk will order the plaques for the first three winners.

Mr. Nester: YEA, Mr. Neu: YEA. Voting: Nay: None. MOTION CARRIED

before the meeting: hearing none Mr. Neu motioned to adjourn.
