Regular Village Council Meeting
October 10, 2005

Present: Mayor Wyndal Staggs, Keith Staggs, Harry Tolliver, Larry Talbott, Betty Kirkpatrick, Kevin Ogle and Clerk Treasurer Tammie Ogle.
Also Present: Police Chief Jim Canter, Kevin Nickell and Diane Fossitt.

Mayor Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting, as well as the Warrant Register, Fund Status, Revenue Status and Appropriation Status reports, and the September, 2005 Bank Reconciliation. Mr. Ogle made a motion to accept the minutes as presented. Mr. Staggs seconded the motion, and it carried, all voting yes. The Council read and approved all other reports and the Bank Reconciliation.

Mayor Staggs recognized Kevin Nickell, who came to discuss the drainage problems at his home on Adkins Place. The Village had originally asked him to wait to install tiles until we had addressed some of our own drainage problems in that area. Mr. Nickell did as we requested, and is now asking for the Village's help in paying for the work. Mr. Talbott made a motion to pay for the labor for this, not to exceed \$1,400.00. Ms. Kirkpatrick seconded the motion, and the roll call vote resulted as follows: Mr. Ogle-yes, Mr. Tolliver-yes, Mr. Staggs-no, Mr. Talbott-yes, Ms. Kirkpatrick-yes. The motion carried. Mr. Nickell thanked the Council for their help.
