Mayor Bowyer called this special meeting to order to discuss
 the police cruiser purchase and what to do with the old cruiser
 and the old equipment; plus the length of time needed to get
 the new cruiser equipped and ready for street use.

Mayor Bowyer asked for a motion to rescind Ordinance 1993-
 11. A motion to rescind ordinance 1993-11 was made by Mr. Neu
 seconded by Mr. Hanselman. Voting: Neu: YEA, Hanselman: YEA,
 Craig: YEA, Dean: YEA, Johnston: YEA. Voting: NAY: None. MOTION
 CARRIED.

Mayor Bowyer then introduced ORDINANCE 1993-12. AN ORDINANCE
 AUTHORIZING THE CLERK TREASURER OF THE VILLAGE OF HAMERSVILLE
 TO ENTER INTO A CONTRACT WITH 32 FORD FOR THE PURPOSE OF
 ACQUIRING A 1993 FORD CROWN VICTORIA POLICE INTERCEPTOR STOCK
 NUMBER 7201 FOR A PRICE NOT TO EXCEED \$12,500.00 (TWELVE THOUSAND
 FIVE HUNDRED DOLLARS) AND DECLARING THIS AN EMERGENCY.

A motion to suspend the ruled and declaring this an
 emergency was made by Mr. Hanselman, seconded by Mr. Johnston
 .Voting: Hanselman: YEA, Johnston: YEA, Craig: YEA, Dean: YEA,
 Neu: YEA.

Voting: NAY: None. MOTION CARRIED.

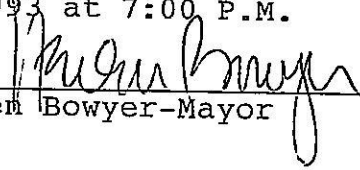
A motion to adopt ORDINANCE 1993-12 was made by Mr. Dean,

 YEA, JOHNSTON: YEA, NEU: YEA. Voting: NAY: None. MOTION CARRIED.

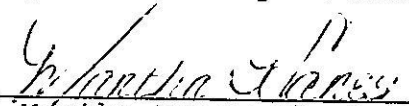
Mayor Bowyer appointed Ms. Craig and Mr. Neu to review
