**RESOLUTION FOR ELECTION ON TAX LEVY EXCEEDING TEN MILL
LIMITATION**

The Council of the Village of Hamersville, Ohio, met in regular session on July 15, 2001

with the following members present:

Council person Talbott moved the adoption of the following resolution:

RESOLVED, by the Council of the Village of Hamersville, Ohio, at least
two-thirds of all members concurring:

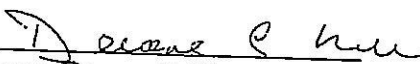
1. The amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the Village of Hamersville and it is necessary to levy a tax exceeding that limitation for Police of the subdivision pursuant to Section 5705.19(a) of the Ohio Revised Code.
2. The proposed levy is a replacement and increase of an existing levy of 1 mill outside of the ten-mill limitation, approved by the voters in November, 1996. The replacement and increase levy will constitute a tax of 2 mills for each dollar of valuation, which amounts to \$0.20 for each \$100 of valuation.
3. The levy shall remain in effect for five (5) years for the tax years.
4. The Clerk Treasurer of the Village of Hamersville shall certify a copy of this resolution to the Board of Elections of Brown County not later than August 23, 2001 and request the Board to provide for notice of the election as required

by law.

Council person Craig seconded the motion, and the roll was called on its adoption, with the following results:

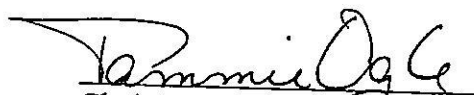
