**Regular Village Council Meeting**  
 February 12, 2007

Present: Mayor Wyndal Staggs, Harry Tolliver, Larry Talbott, Keith Staggs, Roy Day, Jack Shouse and Clerk Treasurer Tammie Ogle.

Mayor Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting to the Council, as well as the Warrant Register, Fund Status, Revenue Status and Appropriation Status Reports, and the January 2007 Bank Reconciliation. Mr. Staggs made a motion to accept the minutes, and Mr. Tolliver seconded it. The motion carried, all voting yes. All other reports and the Bank Reconciliation were read and approved.

Mayor Staggs recognized Larry Reid, who is building a house on Main Street, and needs a house number. Mayor Staggs will take care of it.
