Mr. Hill talked to Mt. Orab Dodge about donating a truck to the Village.

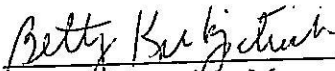
There were 57 children here for pictures with Santa. Jack thanked everyone who helped.

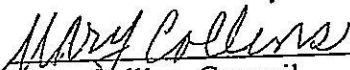
There is a residence on Wayne Avenue whose utilities have been shut off for a year. They are setting trash out. The Council told Jack and Jason to put it in our dumpster.

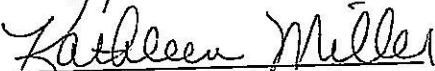
The Police Department made a major arrest last week. We are able to sponsor four children for Shop With a Cop.

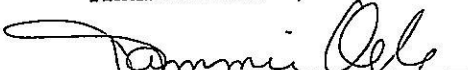

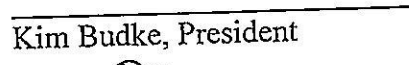
Ms. Budke made a motion to adjourn, and Ms. Collins seconded it. The motion carried, all voting yes.

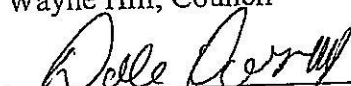
