Ms. Kirkpatrick made a motion to pay all bills. Mr. Tolliver seconded the motion, and it carried, all voting yes.

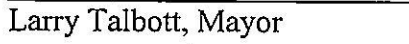

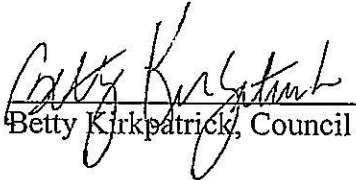
The roof at the Police Department/Mayor's Court building is leaking. Mayor Talbott will talk to the Township Trustees.

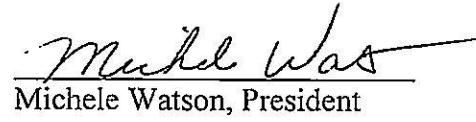
Mr. K. Staggs made a motion to adjourn, and Mr. Tolliver seconded it. The motion carried, all voting yes.

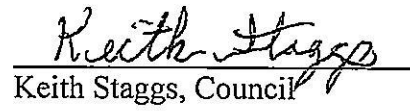
