Regular Village Council Meeting
November 10, 2003

Present: Mayor Wyndal Staggs, Kevin Ogle, Betty Kirkpatrick, Larry Talbott, Harry Tolliver and Clerk Treasurer Tammie Ogle.

Mr. Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance. The Clerk Treasurer presented the minutes of the previous month's meeting, and Mr. Ogle made a motion to accept the minutes as presented. Ms. Kirkpatrick seconded the motion, and it carried, with all members voting yes. The Clerk Treasurer presented the Bank Reconciliation for October, 2003, to the Council, and it was accepted.

Mr. Staggs suggested buying plastic containers for the records we are keeping. Mr. Ogle made a motion to have Mr. Staggs buy 20-25 of them on sale. Ms. Kirkpatrick seconded the motion, and it carried, all voting yes. Mr. Staggs asked if anyone had a problem with his having an ID made, and the Council agreed to have him do so.

Mr. Talbott made a motion to accept the bid from Cornett's for snow removal at \$50.00 per hour. Ms. Kirkpatrick seconded the motion, and it carried, all voting yes.

Mr. Staggs has had a lot of complaints about the drainage on Fite and Adkins Place. He presented pictures. The problem on Fite could be fixed by putting in a bigger culvert. The Street Committee will go to Fite one afternoon or weekend to check it out. Mr. Ogle will have Ronnie Blair shoot the area on Adkins with his laser to find out if Mr. Ogle's idea about the ditches is feasible.

Mr. Ogle made a motion to contract with Scott Gusweiler as Magistrate at the same rate for another year. Ms. Kirkpatrick seconded the motion, and it carried, all member voting yes. We will have Cecelia draw up the contract.

Diana and Bo Shurmake have offered to work on the Christmas decorations again. Kenny will take them to their house.

Mr. Ogle made a motion to adjourn, and Ms. Kirkpatrick seconded the motion. The motion carried, all voting yes.
