The Council discussed, and agreed, that the Police Department needs to patrol more at night.

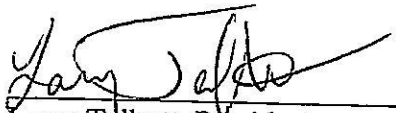

Mr. Ogle made a motion to go into Executive Session to discuss personnel. Mr. Shouse seconded the motion, and it carried, all voting yes.

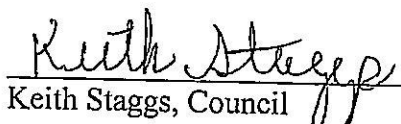
Mr. Ogle made a motion to leave Executive Session, and Mr. Staggs seconded it. The motion carried, all voting yes.

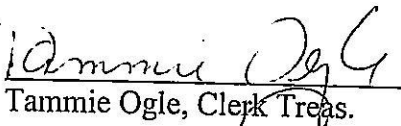

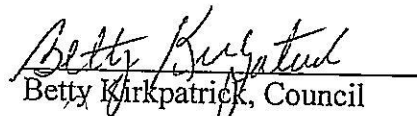
Mr. Ogle made a motion to adjourn. Ms. Kirkpatrick seconded the motion, and it carried, all voting yes.

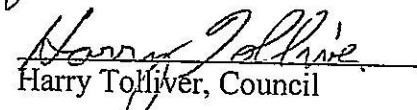
