

ORDINANCE NO. 1983-9

AN ORDINANCE TO INCREASE THE ELECTRIC RATES
CHARGED TO THE ELECTRIC CUSTOMERS OF
THE VILLAGE OF HAMERSVILLE, OHIO

BE IT ORDAINED by the Council of the Village of Hamersville, Brown County, Ohio, three-fourths (3/4) or more of all members thereof concurring as follows:

SECTION I. WHEREAS, the cost of purchasing electric utility service from the Cincinnati Gas & Electric Company has increased to the Village of Hamersville and upon reviewing such increases it appears to the Board of Public Affairs that in order to maintain the solvency of the electric fund, it is necessary and recommended by the Board of Public Affairs that increases be made in the rates charged to customers of the electric utility service of the Village of Hamersville, Ohio.

SECTION II. RESIDENTIAL SERVICE RATE

The Residential Service Rate shall apply to single family residential consumers for all domestic uses. Detached buildings such as garages and/or barns, if used solely for residential purposes, may be served from the residential meter. Effective for service on and after November 15, 1983, to be billed January 1, 1984, the following monthly rates and charges, also known as a rate schedule, shall be applied:

First	40 kwh	at	11.926 per kwh
Next	40 kwh	at	10.336 per kwh
Next	140 kwh	at	7.907 per kwh
Any additional kwh		at	5.428 per kwh

There will be a Fuel Add On Cost, which will be adjusted monthly according to the cost from the Cincinnati Gas & Electric Company. The fuel cost for October, 1983 from the Cincinnati Gas & Electric Company was 0.001001 cent per kilowatt hour.

SECTION III. COMMERCIAL SERVICE RATE

The Commercial Service Rate shall apply to all consumers for general light and power service for purposes other than residential use. As used herein, the term "for purposes other than residential use" shall be construed to include those situations where electrical power is consumed by the user in connection with the operation of a business such that electricity

so consumed is directly used in the business operations as opposed to being merely incidental thereto. Detached buildings, garages and/or barns used in connection with the operation of a business may not be served through a residential meter.

Effective for service on and after November 15, 1983, to be billed January 1, 1984, the following monthly rates and charges, also known as a rate schedule, shall be applied:

First	40 kwh	at	13.252 per kwh
Next	40 kwh	at	11.482 per kwh
Next	140 kwh	at	8.785 per kwh
Any additional kwh		at	6.028 per kwh

There will be a Fuel Add On Cost, which will be adjusted monthly according to the cost from the Cincinnati Gas & Electric Company.

SECTION IV. A penalty of ten percent (10%) will be added to any bill which is not paid on or before the 20th day of the month in which it is due. If the bill has not been paid by the last day of the month in which it is due, service will be discontinued.

SECTION V. This Ordinance is hereby declared to be an emergency Ordinance in that it is necessary for the public health safety and welfare of the inhabitants of the Village of Hamersville, Ohio, and more particularly so that adequate electric rates and charges can be made so as to maintain the electric fund of said Village in a solvent condition and so that adequate utility service to the inhabitants of the Village of Hamersville, Ohio can be provided and this Ordinance shall be in immediate effect upon its passage.
