Regular Village Council Meeting
June 14, 2004

Present: Mayor Wyndal Staggs, Larry Talbott, Harry Tolliver, Eric Johnson, Betty Kirkpatrick, Keith Staggs, and Clerk Treasurer Tammie Ogle.

Also Present: Police Chief Jim Canter, Kenny Green and Mike Salisbury.

Mayor Staggs called this regular meeting to order at 7:00 p.m., and then led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting, as well as the Warrant Register, Fund Status, Appropriation Status, Revenue Status reports and the Bank Reconciliation for May, 2004, which the Council read and approved. Ms. Kirkpatrick made a motion to accept the minutes as presented. Mr. Talbott seconded the motion, and it carried, all members voting yes.

Mayor Staggs introduced Mike Salisbury. Ms. Kirkpatrick made a motion to contract with Mike to mow and do sewer maintenance when needed, using Village equipment, at \$8.50 per hour. Mr. Staggs seconded the motion, and it carried, all voting yes.
