

COUNCIL OF THE VILLAGE OF HAMERSVILLE, OHIO
RESOLUTION NO. 1984-2

DECLARING THE AMOUNT OF TAXES THAT MAY BE RAISED
BY LEVY AT THE MAXIMUM RATE AUTHORIZED BY LAW
WITHOUT A VOTE OF THE ELECTORS TO BE INSUFFICIENT
AND DECLARING THE NECESSITY OF AN ADDITIONAL LEVY
IN EXCESS OF SUCH RATE

BE IT RESOLVED by the Council of the Village of Hamersville
State of Ohio, two-thirds (2/3) of all members elected thereto
concurring:

SECTION I. That the amount of taxes that may be raised by
the levy of taxes at the maximum rate authorized by RC 5705.02 on
the taxable property in said Village will be insufficient to
provide adequate amount for the necessary requirements of said
Village; and that it is necessary for the purpose of continuing
to provide adequate funds for current expenses that taxes be
levied on the taxable property in said Village for the period of
five (5) years at a rate in excess of such maximum rate
authorized by said RC 5705.02.

SECTION II. That it is necessary to levy taxes for the
years 1984, 1985, 1986, 1987 and 1988 at the rate of each year of
1.7 mills on each dollar of tax valuation of the taxable property
within the Village of Hamersville, Ohio in excess of the rate
authorized by said RC 5705.02. This is a renewal levy.

SECTION III. That the Clerk be and hereby is directed to
certify a copy of this Resolution to the Board of Elections
of Brown County, Ohio, in order that the Board of Elections may
make the necessary arrangements for the submission of such
question to the electors of said Village, as provided by law.

SECTION IV. That this resolution is hereby declared to be
an emergency measure for the immediate preservation of the public
peace, health, safety and welfare of the inhabitants of the
Village of Hamersville, Ohio and for the further reason that it
is necessary to comply with requirements for the submission of
the tax levy referred to herein; therefore, this resolution
shall be in full force and effect from and immediately after its
adoption.
