Regular Village Council Meeting
 April 12, 2010

Mayor Talbott called this regular meeting to order at 7:00 p.m., and then the led the assembly in the Pledge of Allegiance.

The Clerk Treasurer presented the minutes of the previous meeting to the Council, as well as the Warrant Register, Revenue Status, Appropriation Status and Fund Status reports, and the March, 2010 Bank Reconciliation. Ms. Kirkpatrick made a motion to accept the minutes, and Ms. Watson seconded it. The motion carried, all voting yes. All other reports and the Bank Reconciliation were read and approved.

Mayor Talbott recognized Wayne Blakely, who came to discuss the water flow at 9977 Fite Avenue. Ms. Potts told him that he may need to have a Title search done.

Mayor Talbott recognized Edna Pride, who asked about an alley leading to her property. Someone has built a garage too close to it, and they have parked a vehicle on it. She discussed the legalities with Ms. Potts.

Mayor Talbott recognized Vince Lindley from AEP. He told Council that basically the electric service would not change as far as repairs. The cost is \$48.95 mwh today.

Ms. Kirkpatrick made a motion to suspend the rules for reading an Ordinance three times, and Mr. Tolliver seconded it. The motion carried, all voting yes. Ms. Kirkpatrick made a motion to adopt Ordinance 2010-05, raising court costs. Mr. K Staggs seconded the motion, and it carried, all voting yes.

Mr. W Staggs made a motion to adjourn. Ms. Kirkpatrick seconded it, and it carried, all voting yes.
