Regular Village Council Meeting
December 11, 2000

Present: Mayor Duane C. Neu, Clerk Treasurer Tammie Ogle, and the following members of the Village Council: Donnie Sowers, Bill Dean, Kevin Ogle, Wyndal Staggs and Joyce Craig.
Also present: Village Solicitor Cecelia Potts, Kay Elliott, Kenny Green, Police Chief Jim Canter and Karen Roland of the Brown County Press.

Mayor Neu called the meeting to order at 7:00 p.m., then led the assembly in the Pledge of Allegiance.

Mr. Sowers made a motion to accept the minutes as presented by the Clerk Treasurer. Mr. Ogle seconded the motion, and the motion carried, all voting yes.

Council discussed the sewers. Mayor Neu will call Steve Canter at Environmental Engineering about the air valves. Steve will contact Grooms to give them a chance to make good on them first. Mr. Green needs a boom for the tractor. Mr. Dean made a motion to approve what Environmental Engineering recommends, and Mr. Sowers seconded the motion. The motion carried, all voting yes.

Mayor Neu recognized Chief Jim Canter. He has had two personal checks returned this month. Ms. Potts told him to give them 10 days to make it good, then take it to the Prosecutor to press charges. The Clerk Treasurer will make up a form letter to return to them with the checks. Mr. Ogle made a motion to buy a battery charger, and Mr. Sowers seconded the motion. The motion carried, all voting yes. The Mayor will pick it up. Chief Canter also brought up a trailer on Wooster. It has been pulled in and hooked up to the electric-he wants to know if it is legal. Mayor Neu informed Council that they beat the deadline, so it is legal.
