Village Council Meeting
 March 16, 2020

The Council of the Village of Hamersville met in regular session at the Village Municipal Building on Monday, March 16, 2020 at 7:00 p.m. with all members present except Betty Kirkpatrick.

Mayor Hill called the regular meeting to order and then led the everyone in the Pledge of Allegiance.

Public Participation

Ms. Michelle Barger addressed Council regarding the Village's noise ordinance as well as voicing her complaint regarding the continual noise issues with village maintenance crews working during the early morning hours on the weekends. Mr. Harry Tolliver also expressed his concerns with noise issues in the village as well. A discussion ensued regarding the matter with Mr. Sutton, Village Administrator, addressing the residents' concerns.

Mayor Hill requested Council elect the President of Council.

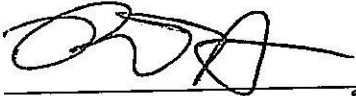
Resolution 20-13

Motion by: Ms. Miller Seconded by: Mr. Owsley

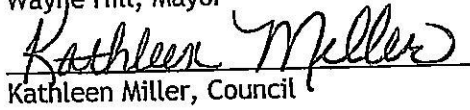
To approve and pay the bills.

There being no further business, Ms. Miller made a motion to adjourn the meeting, seconded by Mr. Wilson, The motion passed unanimously.

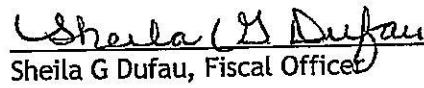

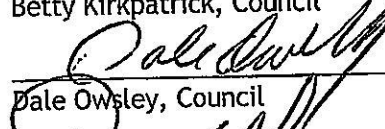
